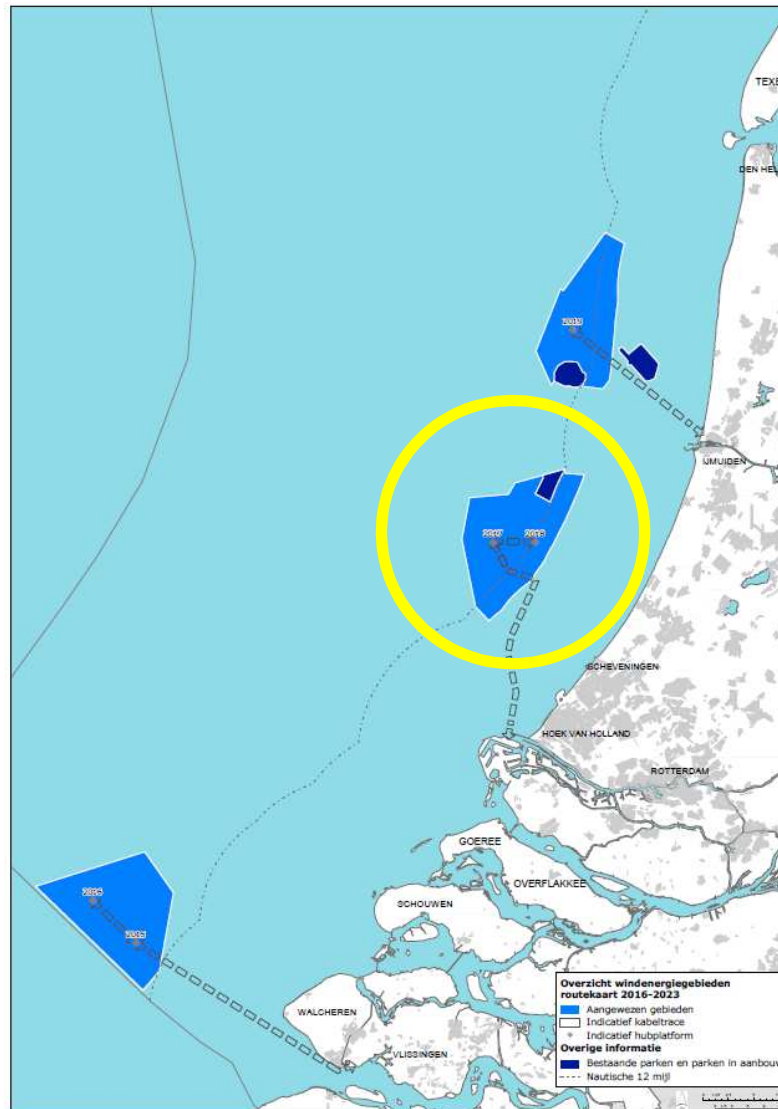

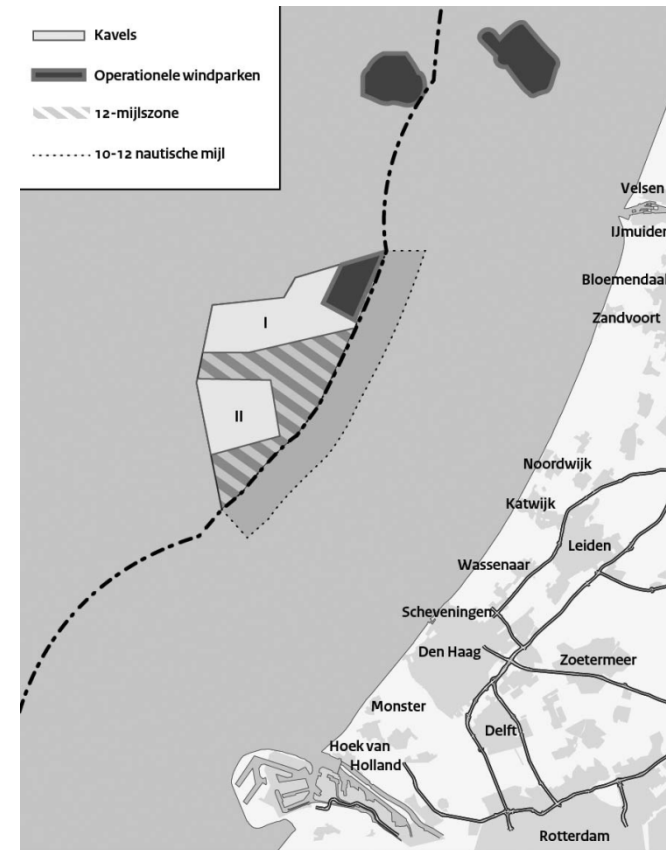

Hollandse Kust (zuid), sites I and II

- Final wind farm site decisions published 16th December 2016
- 7 appeals
- 30th May 2017 hearing Council of State
- Ruling expected after 6 of 12 weeks

Subsidy tender Hollandse Kust (zuid) I+II

Main points

- Publication scheduled for April / May 2017;
- Tender cap of € 0.10750 / kWh;
- Base energy price of € 0.025 / kWh;
- Tender application window: 14-28 September 2017.

Contents

- Very similar to previous tender;
- Per applicant, one individual application per site and one combined application is allowed;
- Legally impossible to only allow a combined bid at this point.



Subsidy tender Hollandse Kust (zuid) I+II

- Turbines boosters not included in installed power. Maximum of 380 MW per site remains;
- Wake effects: only wind farm Luchterduinen and wake of own turbines must be taken into account;
- A combined bid is only valid if an implementation agreement and bank guarantee are issued in advance for both sites;
- If the wind farm site decision becomes irrevocable after the date of issuing the subsidy grant, the wind farm should be put into use 5 years after irrevocability of the wind farm site decision.



Hollandse Kust (zuid), sites III and IV

- Draft scoping document for EIA published 23 December 2016
- 34 views, 9 visitors
- Final scoping document to be published soon
- Draft wind farm site decisions: 2 June – 13 July
- Final wind farm site decisions: expected October 2017
- Irrevocable wind farm site decisions expected Q2 2018

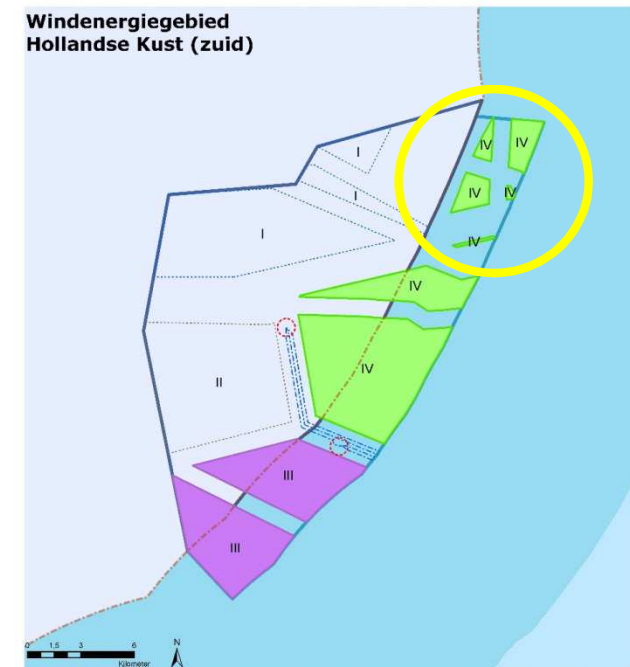




Hollandse Kust (zuid), sites III and IV

Considerations:

- Use of scattered parts of site IV ?
- Under water noise levels: identical to Borssele wind farm site decisions
- Lighting: only outer contours of sites?
- Turbine colours (camouflage)?
