

Offshore Wind Energy in the Netherlands – News

Hollandse Kust (zuid) Wind Farm Sites I and II

Two parties lodged notices of objection with the Netherlands Enterprise Agency (RVO.nl) relating to the decision to issue permits to Chinook CV (Subsidiary NUON- Vattenfall). Both parties have now withdrawn their objection. As a result, the permits are now irrevocable.

Hollandse Kust (zuid) Wind Farm Sites III and IV

On September 28th, 2018 the Minister of Economic Affairs and Climate Policy has informed the Dutch Parliament about the tender procedure for the offshore wind farm zone Hollandse Kust (zuid) Sites III and IV. Part of this procedure is a draft of the Ministerial Order for permitting offshore wind energy HKZWFS III and IV. We [hereby](#) provide you an English translation of the draft version.

This draft version shows that also for this tender, market parties may submit an application for the realisation of the wind farm without subsidies. In the event this tender procedure fails to yield an acceptable bid, a tender procedure including subsidies will be initiated.

From October 2nd until October 10th, 2018, 17:00 hours CEST consultation about this draft version of the Ministerial Order is possible via woz@rvo.nl.

A final publication of the Ministerial Order for permitting offshore wind energy 2018 is expected by the end of October 2018.
