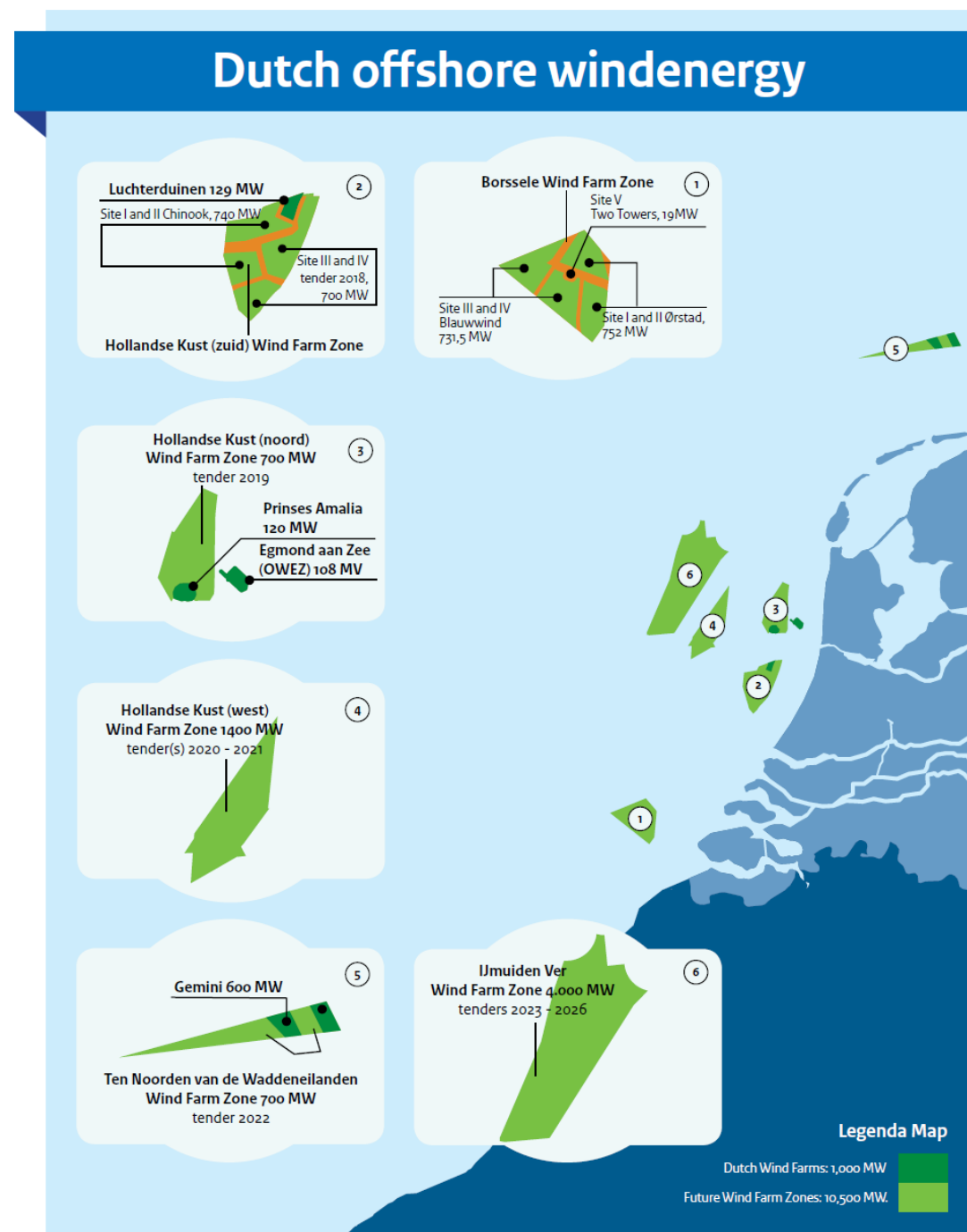

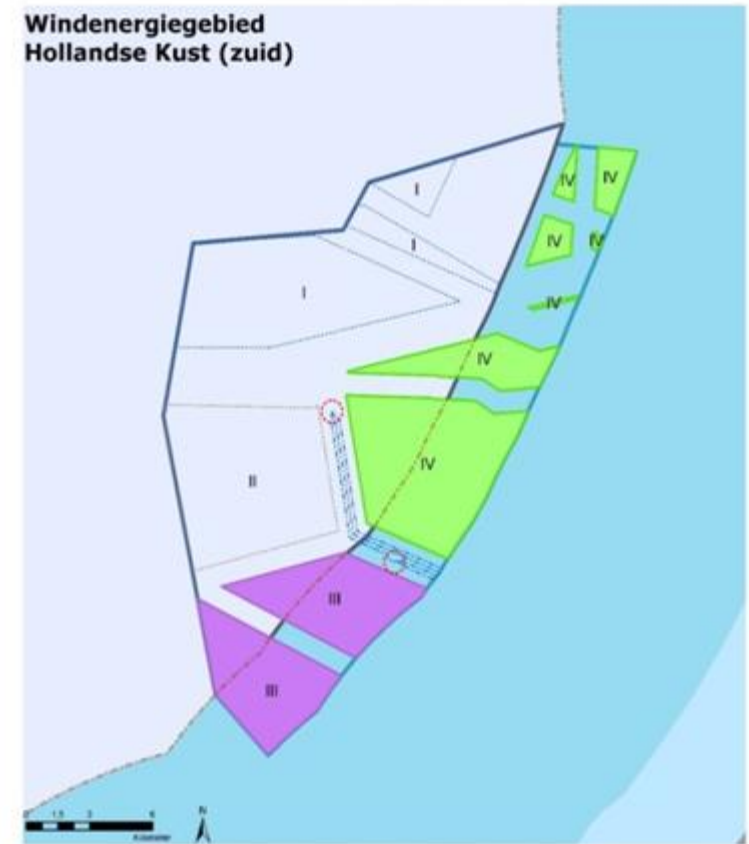

Hollandse Kust (zuid) Sites III/IV

- › Final wind farm sites decisions published 19 January 2018
- › Appeals from 3 parties
- › 15 February 2019: hearing at Council of State
- › 1-14 March 2019: tender
- › 17 April 2019: Verdict Council of State: Wind farm site decisions irrevocable

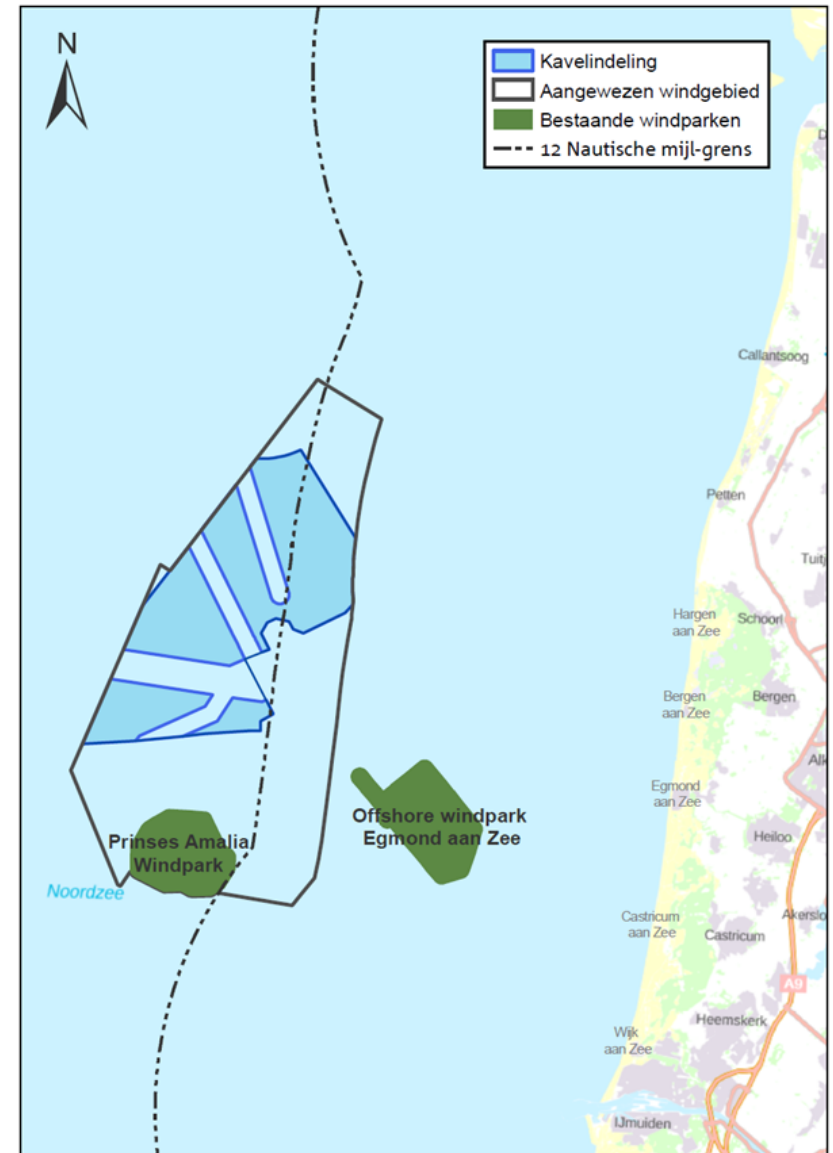

Hollandse Kust (noord) Site V

- › Site decision published 11 April 2019
- › 13 April to 24 May 2019: open for appeal at Council of State
- › Publication Ministerial order expected in Q3 2019
- › Tender (0.7 GW) expected in Q4 2019

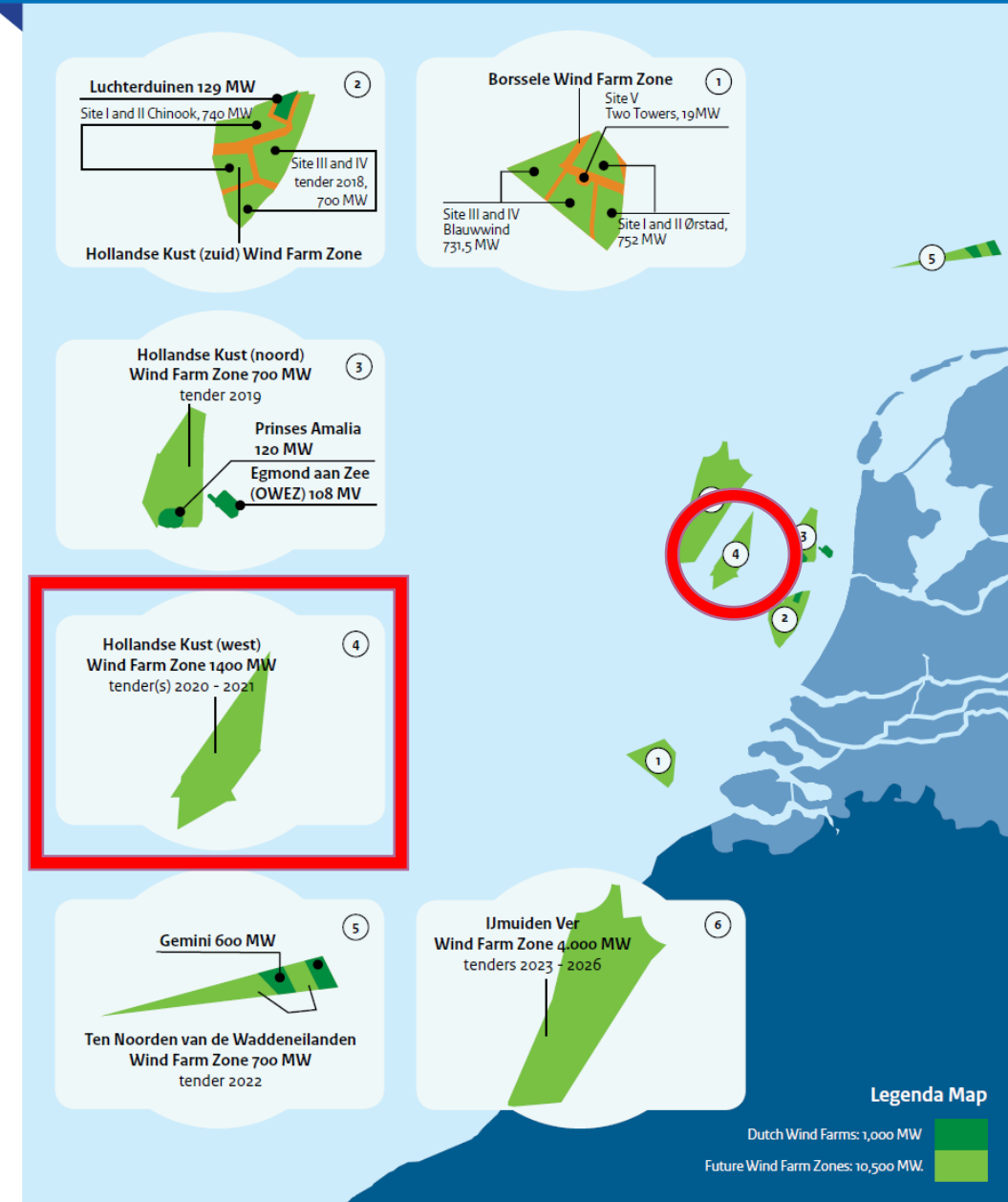

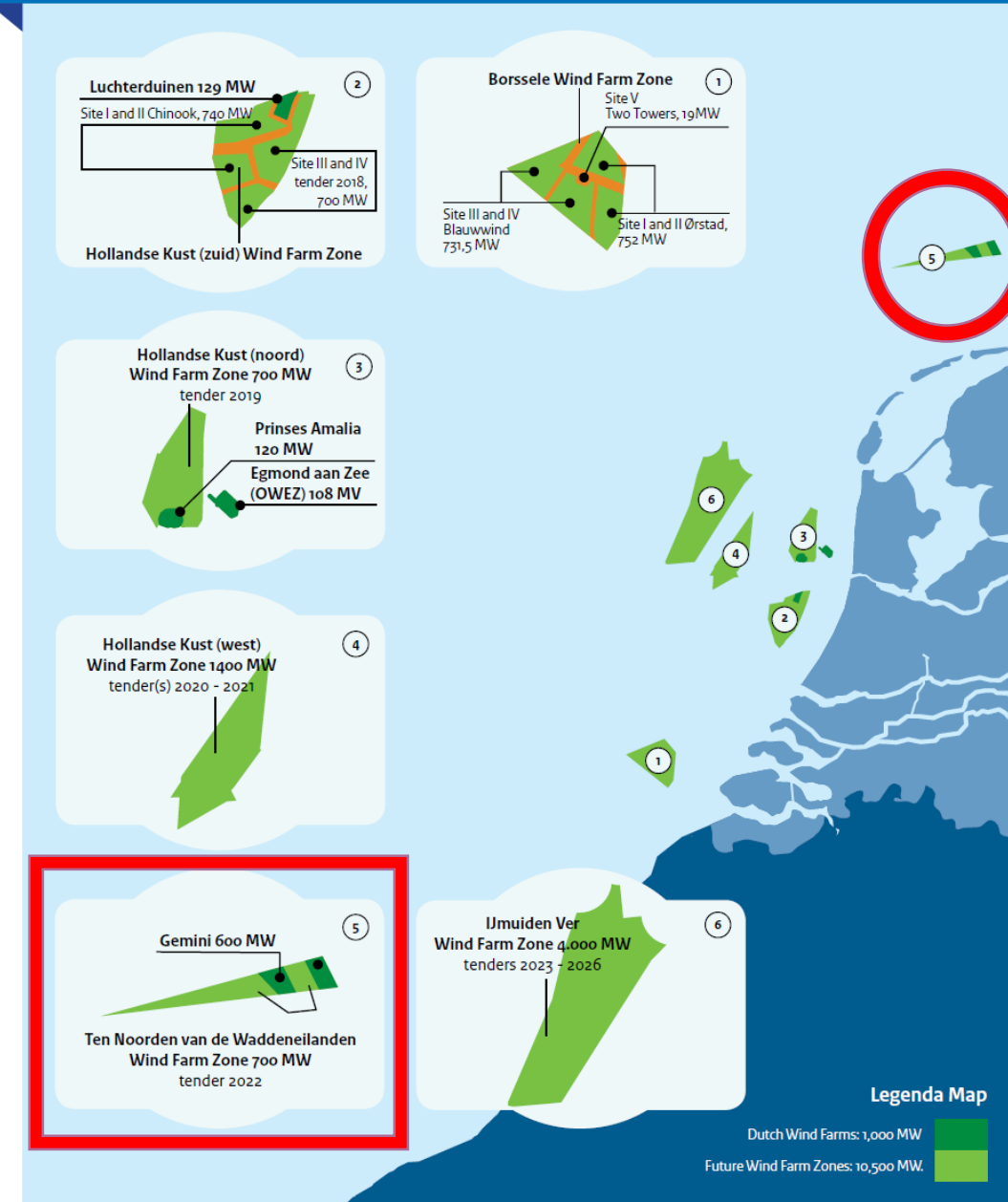

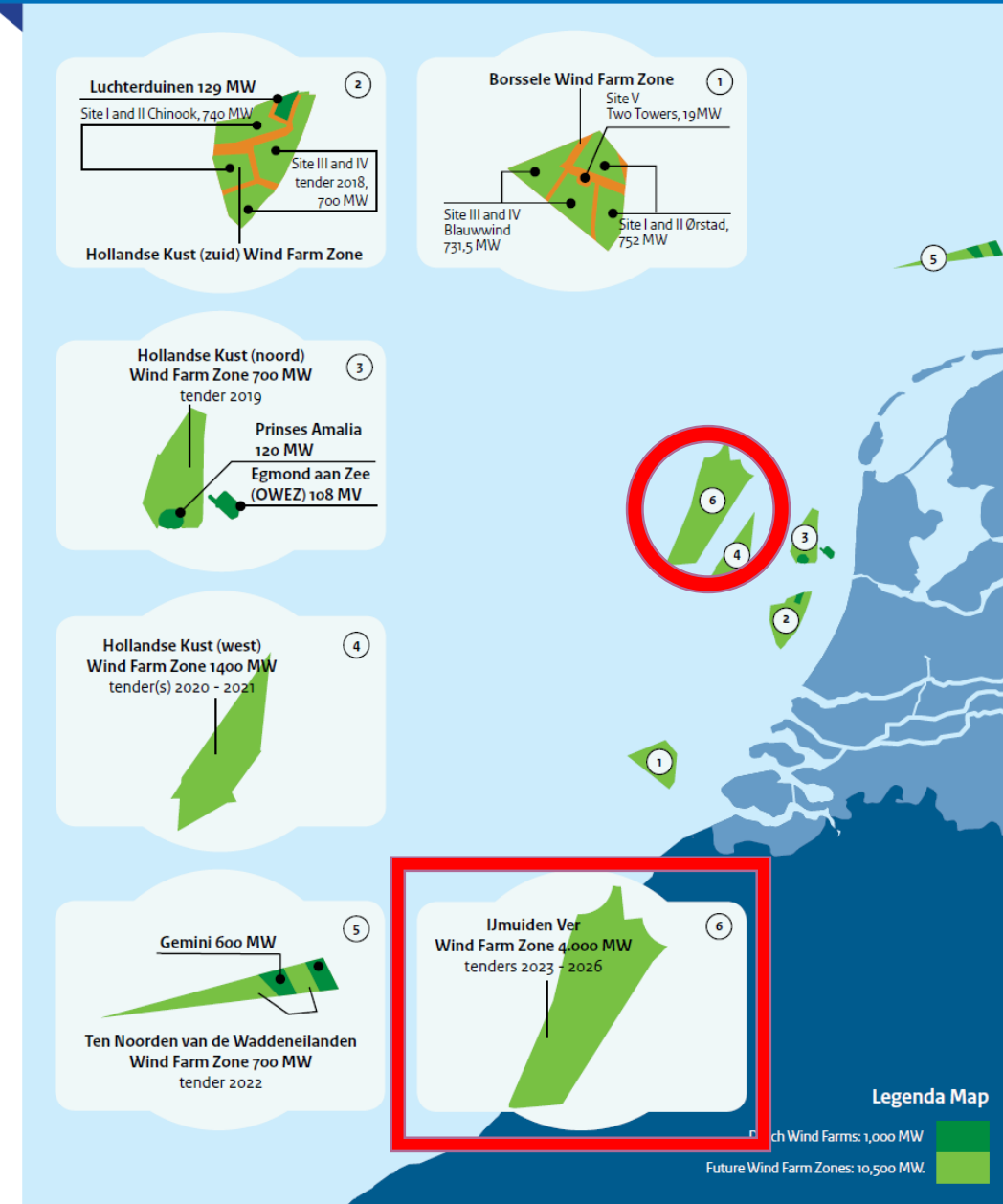

Compensation scheme

- › Short term: Amendment of current Decision
 - Adaption to subsidy-free wind farms: what electricity price to be used?
- › Long(er) term: new Energy Bill
 - Incorporate Borssele experiences
 - Simplification: compensation rather than damage restitution?
