### Workshop: Offshore Wind Energy in the Netherlands – June 30, 2021

On June 30, 2021, from 12.30 – 14.00 hrs CEST, a workshop on Offshore Wind Energy in the Netherlands will be held (in English) via webinar. The Ministry of Economic Affairs and Climate Policy (EZK), Netherlands Enterprise Agency (RVO), Rijkswaterstaat (RWS), and TSO TenneT, will present an update on progress towards achieving the Netherlands' Roadmap goal for 11.5 GW offshore wind power in 2030 along with details on the upcoming Hollandse Kust (west) tender.

Special guest Sander Vergroesen (IRO) will take part in this workshop to discuss the opportunities for offshore wind energy and the supply chain.

#### Dutch Offshore Wind Policy by Joost Vermeulen (Ministry of Economic Affairs and Climate Policy)

Latest developments in the legal framework Dutch offshore wind energy, update on the offshore wind policy, the tender scheme and Roadmap Offshore Wind Energy 2030. Announcement of the development of new approach and Roadmap Offshore Wind Energy 2040.

#### Site studies: Dutch Offshore Wind Farms by Frank van Erp (Netherlands Enterprise Agency)

Status of the studies for Hollandse Kust (west) (HKW), Ten noorden van de Waddeneilanden (TNW) and IJmuiden Ver (IJV) Wind Farm Zones. Intermediate results of our market consultation.

#### Offshore Grid by Saskia Jaarsma (TenneT)

Update and planning on substations and connection to the onshore grid.

#### Upcoming Tenders for Hollandse Kust (west) Wind Farm Zone by Emelie de Wagt (Ministry of Economic Affairs and Climate Policy)

Introduction of the two tenders for this Wind Farms Zone. For each tender a comparative assessment will be held.

#### Hollandse Kust (west) Sites VI and VII Wind Farm Site Decisions by Thomas Collette (Rijkswaterstaat)

Coming up new versions of the published draft Wind Farm Site Decisions. Explanation of the differences compared with the first drafts with regard to permit duration, and nitrogen.

Update on Wind Farm Site Decisions for the Ten noorden van de Waddeneilanden (TNW) and IJmuiden Ver (IJV) (sites I – VI) Wind Farm Zones.

**The workshop ends with the publication of the final Project & Site Description for Hollandse Kust (west) Wind Farm Zone.**
