

- Roadmap 2030 and North Sea Energy Outlook
- 2 wind farm sites: VI and VII (2 x 0,7 GW)
- Shore landing at Beverwijk

Contribution to the energy system

Bandwidth: 3.000.000 MWh – 3.400.000 MWh p/a

Ecological Innovation

- Incentivise investments to benefit the North Sea ecological environment (additional to Site Decisions)
- Focus 30% on roll-out and 70% on innovation
- Differentiate between protected species (+++), unprotected species (++), and nature enhancement (+)
- In both cases points for knowledge sharing and information & adding to existing research

Security of realisation

Knowledge and experience of sub-contractors; equity; parent-company guarantees

Contribution to the energy system

Bandwidth: 3.000.000 MWh – 3.400.000 MWh p/a

System Integration

- Incentivise investments to benefit / increase the scalable flexible demand in line with the supply profile and system integration; off- and onshore
- Focus 70% on roll-out and 30% on innovation
- Needs to be executed on Dutch national territory, but geographical distance to shore landing is not weighted
- Additional to commitments made for wind farm Hollandse Kust (noord)
- In both cases points for knowledge and information sharing
